#### **Test Site Information**

You will need to crate in your car. There is limited shade and the weather varies in September so please bring any necessary supplies for your dog (warm or cold) and remember to pick up after your dog.

All dogs must be on a <u>6' leash</u> at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; flexis may be used in the test itself.

This ORT test is at a Church/School in the GYM. The floors are a mix of concrete and polished wood flooring. The parking lot is asphalt and the pathway to and from the parking lot to the test area are cement however you may have to navigate uneven terrain, including cracked and broken asphalt in places in the parking area. Due to unforeseen conditions, such as weather or change in availability of areas at the location, the expected test area, parking, and/or pathways may be modified at the last minute.

## Entry Requirements

The handler of the dog must be a <u>current member</u> of the NACSW™. The Dog must be registered with the NACSW™. For information on how to register or become a member go to <u>www.NACSW.net</u>

# Trial Eligibility and ORTs

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

## Entry Fee and Second Dog Policy

\$35.00 entry fee per odor per dog.

A maximum of two dogs per odor per handler will be accommodated.

#### **Closing Date**

January 16, 2020 at 8pm (Pacific Time) or when entry limits have been met (maximum of 100 runs).

Overnight mail entries must have the signature request waived.

#### Refund Policy

Entry fees will be refunded (less \$10 admin fee) if notification of your withdrawal from the event is received by Friday, January 4, at 5pm (Pacific Time) and your spot is filled. Notification of cancelations must be emailed to <a href="mailto:rosevillek9nosework@gmail.com">rosevillek9nosework@gmail.com</a>. After this date no refunds will be given.

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, or excused by the NACSW™ official or judge.

# From Reno, Take I-80 West toward Sacramento and From the Bay Area, Take I-80 East towards Sacramento/Reno

From I-80, take exit 102, Riverside Ave. and move into the far-left lane. The first cross street is Cirby Way and you need to be in the inside turn lane. Turn left on Cirby Way and immediately turn left at Melody Lane (the first stop light). Follow Melody Lane for about ½ mile and at the corner it turns into W. Whyte Ave. (this is the corner of the church property). After turning right onto W. Whyte Ave., pull into the gated driveway on the left and you will be directed for parking.

#### **TEST Information - Notice to Exhibitors**

THE TEST SITE will be open from 7am to 5pm or when all tests are completed

**CHECK-IN/HANDLER BRIEFING -** Details regarding check in time and briefing will be <u>emailed</u> approximately 1 week before the ORT. (Valid email address required)

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

#### **ENTRIES:**

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. Return check fee is \$30 and due upon notification.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS
  ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested. Dogs must be on leash at all times. There is no inside crating at this test.

FEMALES IN SEASON – Contact your test host at least 1 day before the ORT if this becomes a possibility. Females in season must run last after all other tests.

**DOGS PARTICIPATING** in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

**Acknowledgement of entry acceptance/CONFIRMATION** will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

**BASIC DESCRIPTION OF TEST** – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of *one or* two rows, spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.
